

Past High Priest Highlight John Charles Schield 1950

SCHIELD, John (Johannes) Charles was born May 21, 1891 in Stetten, Germany the son of Paul and Maria Schild and came to the United States with his parents December 3, 1892. He married Elsie Anna Bettin May 16, 1915 in Chicago and they were the parents of a son, Robert John Charles. He was employed by the Commonwealth Edison Company as a machinist. He was raised a Master Mason November 4, 1944. He was exalted a Royal Arch Mason August 12, 1946 and served as High Priest of the Chapter in 1950. He died January 2, 1975 in Fort Myers, Lee



County, Florida and was buried in the Fort Myers Memorial Gardens Cemetery.

Once again a Brother Mason, having completed the designs laid down on life's Trestle-board, and having answered the last summons of the

Grand Warden of Heaven, has now entered the Celestial Lodge above over which the Supreme Architect of the Universe presides.

Brother Robert Joe Parsons was born August 25, 1943 at Oberlin, Ohio.

He was initiated an Entered Apprentice March 11, 1968, passed to the degree of Fellowcraft April 15, 1968, and raised to the sublime degree of Master Mason May 27, 1968 in Teikoku Lodge No. 19, Okinawa, Japan. He became a Charter Member of Arboretum Lodge No. 1175 on October 7, 1978 and affiliated with Euclid Lodge No. 65 by Consolidation on February 12, 1996. He was a Life Member and a 50 Year member of the Fraternity.

He was called from his labors on earth to eternal refreshment in the Paradise of God on July 14, 2018, at Tinley Park, Illinois.

Thus ends the Masonic record of this just and upright Mason.

COLOR PHOTO that records image and height and is digitized on a convenient CD. This CD can be easily circulated by police to the media and distributed across the State within an hour via Illinois' Amber Alert Program.

RECORDED INTERVIEW captures, on the same CD as the picture, the appearance, speech patterns personal characteristics and mannerisms for easy media distribution.

A DNA SAMPLE taken through a saliva cheek swab is the latest tool in the scientific arsenal to make positive ID's of lost children.

FINGERPRINTS are the oldest form of positive identification since they are unique to every person.

Demolition was begun immediately after our last Special Meeting in June. The brick wall between the kitchen and the women's bathroom was torn out, necessitating the installation of a new steel beam to support the roof. All carpeting was torn out (except Lodge Room) and will be replaced with new wood look flooring. The kitchen will be reduced in size and completely renovated. The old women's bathroom will be enlarged and two urinals added. The old men's bathroom will become a storage closet and the old archives closet will become a second handicap accessible bathroom. The main coat closet will be reduced in size and a new archives closet will take up most of it's space. Chapter/Council closet will be reconfigured for more efficient use of the space. A new bathroom has been installed in the basement. Tentative completion by our Stated Meeting in October. The September Stated Meeting will be held in the basement classroom. Temple Board Member George Murray has been managing this project and doing a great job.

From the Temple Board...

WBro. Don Cowart President, Naperville Masonic Temple Association

I have heard the question asked, "What does the Temple Board do?" I know it seems the Lodge has gone dark in July and returned in September, over the past eight years, with big changes having magically been made. Well,



this is one of the things the Temple Board does. The physical changes we all see, as well as the strategic planning that happens behind the scenes that makes all this possible, has been carefully laid out by the founding members of the Naperville Masonic Temple Association. Prior to our Temple building being built in 1916, the Naperville Masonic Temple Association (known as the Temple Board) was incorporated with the State of Illinois whose responsibilities and activities are directed by the "Articles of Incorporation". The object for which the Temple Board was formed is to promote Masonic, Benevolent and Charitable enterprises and provide suitable accommodations for Masonic meetings and entertainment, and for these purposes, to acquire, hold and use so much real estate and other property as may be necessary to erect, maintain and furnish a building as shall be requisite therefore; and to do all and everything necessary or convenient for the accomplishment of any and all purposes or objects and powers above mentioned or incidental thereto, consistent with the Laws of the State of Illinois.

The founding members of the Temple Board took great care in planning space for income producing tenants on the first floor. This foresight has been critical in enabling the Temple Board to have the means needed to, not only maintain in good order the physical building, but to keep the building ever changing to best meet the current needs of our Masonic bodies. Our Masonic Temple is a "living" building, always adapting to continually meet the evolving requirements and standards of our community. This is, I believe, the core responsibility as set forth by our founding members.

The current eight year renovation has finally come to fruition. Having broken this project into seven bite size pieces, I feel we should be well situated for the next generation to best meet those requirements and standards as dictated by our community in order to best promote and welcome growth. Our lodge is in good order, not that there won't be a few changes and tweaks added from time to time, I'm sure. The founding members of the Temple Board, as well as the founding Lodge members Aylmer Keith and Joe Naper themselves, would be well pleased with the outstanding quality of the Brothers and of the lodge building today.

As a few members may be aware, and as WBro. Tim Ory has reminded me, there have been five prior major renovations to our ever changing building:

1916/1917 - Building is erected

1931 - First floor theater floor is raised to level to provide for retail space. Both first floor merchant spaces that fronted Jefferson St. are removed

1935 - First floor theater floor is lowered again to add a movie theater. The stairwell was moved and reconfigured so the entrance to the



lodge and basement are east of the theater entrance (no longer inside lobby of theater)

1950 - Addition to rear of first floor of building to allow 250 additional seats to theater. Air conditioning is added to the theater.

1978 - Theater floor is raised to level again for retail and a freight elevator is added from the first floor to the basement. All five rooftop skylights are closed off

1991 - Kitchen and bathrooms remodeled and air conditioning (1995) is added to the second floor.

As you can see, our lodge building is truly a "living" entity. However, these changes are always costly. Because of the buildings original design, allowing for income producing tenants on the first floor, the livelihood of the Masonic, Benevolent and Charitable endeavors in Naperville have always and will always be accomplished at the highest standards via the best Temple building possible. The Temple Board funds in no way comingle with any of the Masonic bodies. The Blue Lodge, Chapter, Council and Commandery stand alone financially as well. It is through the member's dues and excellent participation that the Masonic bodies in Naperville continue to strive at the highest level. The goal of the Temple Board is always to keep our Temple Building in such order that best guarantee its members that Naperville Masonry will be given the best opportunity to not only survive, but to thrive.

So please, pardon our dust while this last phase of the renovation extends into September. It most certainly will be worth it. RWBro. Floyd Sullens has inspected the classroom in the basement and certified it acceptable to hold stated meetings. We are good to go in September. I can add that there will be a few additional changes to our lodge coming shortly.
